**F.No.13-19/2018-QC:** In exercise of powers conferred under Section 7(f) of DRAP Act 2012, Drug Regulatory Authority of Pakistan in consultation with the Provincial Governments has been pleased to establish **DRAP's National Task Force** for eradication of spurious and unregistered drugs/therapeutic goods. In compliance to the direction of Supreme Court of Pakistan and direction of Honorable Secretary of the Ministry of National Health Services Regulation and Coordination vide letter No. Dy.3066/2018-Secy/NHSR&C dated 02<sup>nd</sup> May 2018 for filing quarterly progress reports about the actions taken to curb the subject mentioned menace of Spurious and unregistered drugs for the perusal of Honorable Supreme Court of Pakistan in Chambers.

2. Drug Regulatory Authority of Pakistan in consultation with the provincial Health departments has been pleased to re-notify “**DRAP’s National Task Force for eradication of spurious/unregistered drugs.**” During the meeting of the DRAP officers and representatives of Provincial Governments on 03-05-2018, following decisions were made:-

- i. The period of activity of National Task Force was extended till satisfaction of the Honorable Supreme Court. Quarterly Progress report will be submitted in the Honorable Supreme Court of Pakistan for their perusal.*
- ii. Provincial Focal persons are requested to forward the consolidated report of respective provinces on daily as well as monthly basis. Provincial inspection teams shall also continue to forward progress reports to DRAP focal person through e-mail (ntf\_drap@dra.gov.pk) and whatsapp group (National Task Force). Monitoring of activities by the inspection teams will be done by provincial and DRAP focal persons at their respective areas.*
- iii. Additional Directors of DRAP at field offices Lahore, Karachi, Islamabad & Peshawar are re-appointed as focal persons for the DRAP teams. Accordingly, Mr. Asim Rauf, Additional Director, DRAP, Lahore Focal Person for Punjab Mr. Najam us Saqib, Additional Director, DRAP Karachi for Sindh. Dr. Hafsa Karam*

***Elahi Focal person for Islamabad and Mr. Abdul Sattar Sohrani Additional Director, Peshawar for KPK. It was also decided that Mr. Abdul Sattar Sohrani will also be the DRAP focal person for the National Task Force. Mr. Fakhruddin Amir Additional Director QA/LT will supervise the implementation of the decisions of Central Licensing Board to ensure timely execution by the DRAP inspectors.***

- iv. It was also decided that meeting of the core committee of National Task Force comprising of DRAP officers and Provincial representatives will be held on monthly basis to review the progress report and for further planning to ensure compliance in the light of directions of Supreme Court of Pakistan.***

3 Performance awards/certificates were awarded by the CEO DRAP to the best performers as per nominations by the Provincial Governments. Provincial Health Departments are requested to provide logistics support and other resources to the filed officers for effective outcome.
