
NOTIFICATION

S.R.O. *SD* (I)/2021.— In exercise of the powers conferred by clause (a) of section 7 of the Drug Regulatory Authority of Pakistan Act, 2012 (XXI of 2012) read with section 12 of the Drugs Act, 1976 (XXXI of 1976), the Drug Regulatory Authority of Pakistan with the approval of the Federal Government is pleased to fix maximum retail prices specified in column (4) of the Table below on which the drug specified in column (2) thereof, having packing sizes specified in column (3) of that table, shall be sold, subject to the conditions specified in paragraph 2 of this notification, namely:-



- (b) maximum retail price as mentioned in column (4) of the Table shall not be applicable on drug whose registrations under sub-rule (4) of rule 29 of the Dugs (Licensing, Registration and Advertising) Rules, 1976 were issued before the issuance of this notification, unless otherwise stated expressly.
