Subject: **Availability/Sale of Unauthorized stock of potentially counterfeit Prevenar Vial Prevenar PFS Registration No. 066110 Marketed by Wyeth Pakistan Limited.**

I am directed to refer to the subject cited above please find enclosed herewith the complaint of M/s Wyeth Pakistan Ltd Pakistan Karachi vide letter No.CF/QZ/01/2020 dated 27-02-2020 which is self explanatory.

02. It is therefore, requested that legal action may be initiated on the availability of un-registered/ spurious Prevenar vaccine in vial because it is neither registered nor manufactured by M/s Wyeth Karachi. They have only registration of Prevenar prefilled syringe (PFS) under Registration No.066110.
