REVOCATION OF FORM-6 (PROVISIONAL CERTIFICATE FOR ENLISTMENT AS MANUFACTURER/IMPORTER) & FORM-7 (PROVISIONAL CERTIFICATE FOR ENLISTMENT OF PRODUCTS).

I am directed to refer the subject cited above and to communicate the following decision of Enlistment Evaluation Committee (EEC) taken in its 123rd Meeting held on 27th June, 2024:

"Decision: The Enlistment Evaluation Committee (EEC) after threadbare deliberations, keeping in view the recommendations of the panel of inspectors and request of the firm (M/s. ALAQ Laboratories) for allocation of same Enlistment number i.e. Form-6 (E.No.0089) decided to accede the request of the firm for shifting of their factory from address "5-Main Road, Amir Town, Lahore-Pakistan", to new relocated factory at "43-D Sundar Industrial Estate, Lahore", and decided to grant the same provisional enlistment number at new address as manufacturer for the following section(s) to M/s. ALAQ Laboratories, located at 43-D Sundar Industrial Estate, Lahore:

- ii. Oral Powder Section (Nutritional Supplement)

- viii. Oral liquid Section (Herbal/Unani)

Hence the provisional enlistment number 0089 at 5-Main Road, Amir Town, Lahore-Pakistan stands revoked with immediate effect. Therefore, provisional enlistment of products at the said premises stand revoked. Manufacturing of Alternative Medicines & Health Products at 5-Main Road, Amir Town, Lahore-Pakistan is prohibited and punishable offence under Rule 11 of the SRO 412(I)/2014 read with Schdule-II and Schdule-III of the DRAP Act, 2012."
