SWITCH OVER FROM WEB BASED ONE CUSTOMS (WEBOC) TO PAKISTAN SINGLE WINDOW (PSW) FOR SUBMISSION AND ISSUANCE OF ALL TYPES DRUG IMPORT LICENSES (DILs) AND ISSUANCE OF ELECTRONIC RELEASE ORDERS THROUGH PSW'S SINGLE DECLARATION (SD) PSW SYSTEM

Reference is made to circular received from Chief Domain officer, Pakistan Single Window, reference no. No PSW/CDO/DOM-538/2024, dated 25-09-2024, regarding subject cited above (copy enclosed).

2. PSW is an Integrated Digital Platform that allows parties involved in trade to lodge standardized information and documents with a single-entry point to fulfill all import, export, and transit-related regulatory requirements. Phase-I of the DRAP-PSW module was launched in February-2024 and currently various processes related to import-export of pharmaceuticals are live in PSW system.

3. Initially, all import-export matters related to Karachi sea port and dry port have been switched to PSW with effect from 15th August 2024. Now the clearance of commercial imports (HC type) of all commodities (Drugs) requiring Drug Import License (DIL) mandated by Drug Regulatory Authority of Pakistan (DRAP) being imported at customs stations of **Peshawar and Islamabad** are being switched from WeBOC to PSW system. All the **DRAP related commodities (Drugs)** will be completely shifted over to PSW, and clearance will be subject to electronic issuance of Release Order by DRAP through filing of Single Declaration (SD) **with effect from 08th October 2024** on all customs stations located in Peshawar and Islamabad.

4. All DML holders / importers / Hospitals / government institutions / Trusts / NGO's etc. engaged in import of above-mentioned commodities falling under the purview of DRAP are hereby informed to file **Single Declaration (Imports)** through PSW System for issuance of electronic Release Order from DRAP and Customs clearance of their import consignments, being imported

at customs stations of Peshawar and Islamabad with effect from 08th October 2024. It is requested to comply with the circular in true letter and spirit.

5. This issues with the approval from CEO, DRAP.


