DRAP-PSW GATEWAY: ONLINE APPLICATION FOR PHARMACEUTICAL EXPORT CERTIFICATES

I am directed to refer to the subject cited above. In line with the direction of Honorable Prime Minister to digitize the regulatory processes, Drug Regulatory Authority of Pakistan (DRAP) has been actively pursuing digitalization initiatives. These efforts aim to streamline operations, reduce processing times, and improve overall efficiency. A key component of this digital transformation is the integration of various services with Pakistan Single Window (PSW) system, which serves as a unified platform for trade-related regulatory requirements. Phase-I of the DRAP-PSW module, launched in February 2024, represents a significant step in this direction.

- 2. A key component of this digitalization drive is the streamlining of export procedures. DRAP is proudly writing to inform you of an important update regarding the submission and processing of applications for export-related certificates. Effective immediately, the DRAP-PSW (Pakistan Single Window) Gateway will serve as the exclusive platform for the submission and processing of applications for the following certificates:
 - i. Export No Objection Certificate (NOC)
 - ii. Certificate of Pharmaceutical Product (CoPP)
- iii. Free Sale Certificate (FSC)
- iv. Good Manufacturing Practices (GMP) Certificate
- 3. This transition is aimed at improving the efficiency and transparency of the export certification process, ultimately benefiting the pharmaceutical industry and promoting Pakistan's pharmaceutical exports. To ensure a seamless transition to this digital platform, DRAP has already conducted virtual training sessions for stakeholders. All pharmaceutical

manufacturers and exporters are advised to familiarize themselves with the DRAP-PSW Gateway and utilize it for all export certificate applications. DRAP is committed to providing the necessary support and guidance during this transition. Please be advised that 1st May, 2025, has been set as the definitive cut-off date for manual submissions.

4. We appreciate the cooperation of Pakistan Pharmaceutical Manufacturer Association (PPMA) and Pharma Bureau in disseminating this information to your members.
